Protection for your most valuable assets

If you become injured during the operative time of the policy, you can incur significant financial losses as a result. Personal accident insurance can help offset some of these unexpected expenses.

This insurance can pay out a set amount if someone is injured in an accident and the pay out can be a lump sum or a weekly amount. It ensures all participants have protection in the event of an injury and because this is a "non-negligence" cover it can help reduce litigation because unlike a liability policy you do not have to find someone to be at fault for an injury to receive compensation.

Technical Officials

Whilst participating as a technical or motorcycle official as part of an organised official activity recognised by the Insured and including direct travel between the Insured Person's place of resident and the venue of an organised official activity recognised by the Insured anywhere in the world.

Core Member

- Whilst training, practicing and dire travel between the Insured Person's place of residence and the venue of an organised, permitted event recognised by the insured anywhere within the United Kingdom.
- Whilst racing/competing in an ETU/ITU sanctioned event anywhere in the World.
- Excluding any travel to or from a place of work whether direct or not in all instances

Core Coach

- Whilst training, practicing, coaching and direct travel between the Insured Person's place of residence and the venue of an organised, permitted event recognised by the insured anywhere within the European Union.
- Whilst racing/ competing in a ETU/ ITU sanctioned event anywhere in the World.
- Excluding any travel to or from a place of work whether direct or not in all instances.

Ultimate Coach

- Operative Time: Whilst training, practicing, coaching and direct travel between the Insured Person's place of resident and the venue of an organised, permitted event recognised by the Insured anywhere in the world.
- Whilst racing/ competing in British Triathlon Permitted Events and racing at ITU or Continental (ATU, ASTC, CAMTRI, ETU, OUT), IRONMAN, Challenge, Powerman, Xterra and Super League Triathlon sanctioned events
- Excluding any travel to or from a place of work whether direct or not in all instances.

Ultimate Member

- Whilst training, practicing and direct travel between the Insured Person's place of resident and the venue of an organised, permitted event recognised by the Insured anywhere in the world.
- Whilst racing/competing in British Triathlon Permitted Events and racing at an ITU or Continental (ATU, ASTC, CAMTRI, ETU, OUT), IRONMAN, Challenge, Powerman, Xterra and Super League Triathlon sanctioned events.
- Excluding any travel to or from a place of work whether direct or not in all instances.
